#### **Action Items**

Recommendation from Investment Committee to transition from CastleArk to Northern Trust Index Fund

**Motion: Mr. Saunders seconded a motion based upon the recommendation of the Investment Committee and Summit Strategies to transition assets from Castleark – Large Cap Equity to a Northern Trust Index Fund for fee of 4 basis points subject to the review and recommendation of a satisfactory investment manager’s agreement by Attorney Aslinger, and to authorize Ms. Paczkowski to execute the approved agreement and proceed with all action necessary or convenient to properly effect this investment manager’s appointment and implement the investment manager’s agreement. Ms. Blanc seconded the motion. The motion passed 8-0.**

Recommendation from Investment Committee to Fund Standish for Global Fixed Income Mutual Fund

**Motion: Mr. York made a motion to amend the recommendation from the Investment Committee to fund Standish with 5% of assets for a Global Fixed Income Mutual Fund to instead use a comingled fund with Standish. Mr. Saunders seconded the motion. The original motion as amended passed 8-0.**

#### **Plan H**

Mr. York discussed with the Board the need to develop strategies to shield the Plan H employee accounts from market risk as the plan members and Plan H assets increase. The Board charged the Investment Committee with the task of developing, with Summit Strategies, a separate Investment Policy and asset allocation for Plan H as soon as practicable.

#### **Additional Investment Committee Member**

**Motion: Mr. Saunders made a motion recommending Mr. Dennis Owen be added as a member to the Investment Committee. Ms. Blanc seconded the motion. The motion passed 8-0.**

Ms. Blanc advised the Board of a congratulatory letter she received from a citizen upon becoming a trustee to the Pension Board.
