Average monthly salary for 2 highest 12 month periods, \$5,526.71 x .025 =
\$138.17 x 29.21324 = \$4,036.39. Mr. Coker chose Option A-6 – 100% without reinstatement to
Susan R Coker, spouse. \$4,036.39 x .8755 =
\$3,533.86 pension effective April 1, 2016.

Motion: Mr. Paseur made a motion to approve this application for normal retirement payable under Option A-6. Mr. Saunders seconded the motion. The motion passed 8-0.

13. APPLICATION FOR PARTICIPATION IN THE DELAYED RETIREMENT OPTION PROGRAM (DROP): PURSUANT TO CHARTER SECTION 1371.8 – PLAN G.

The following employees have chosen a Delayed Retirement Option and will receive a one-time payment of the accumulated monthly benefits on termination of employment with the City of Knoxville.

- a) William J Walsh, General Government – Plan G1 No Option
Date of birth, April 24, 1955: 60 years of age
Total credited service: 28 years 10 months 4 days
Plan A benefit: Average base salary for 2 highest 12 month periods, $\$400.00 \times .0081\% = \$3.24 \times 10.08333 = \$32.67$ plus average excess salary for 2 highest 12 month periods, $\$7,880.70 \times .0162\% = \$127.67 \times 10.08333 = \$1,287.34$; Total A benefit = $\$32.67 + \$1,287.34 = \$1,320.01$.
Plan G1 benefit: Average monthly salary for 2 highest 12 month periods, $\$8,280.70 \times .0115\% = \$95.23 \times 18.76096 = \$1,786.61$. Plan A benefit $\$1,320.01$ + Plan G1 benefit $\$1,786.61 =$
***\$3,106.62** pension effective April 1, 2016.
DROP complete March 31, 2018.

*Defined benefit only – member chose to receive the value of the supplemental retirement account (defined contribution) in a one-time lump sum payment pending the 3/31/2016 account valuation.

Mr. Paseur made a motion to approve this application for DROP retirement. Mr. King seconded the motion. The motion passed 8-0.

- b) Martin L Clay, General Government – Plan G2 Option A-6
 100% without reinstatement
Date of birth, March 1, 1952: 64 years of age
Total credited service: 10 years 5 months 15 days
Average monthly salary for 2 highest 12 month periods, $\$4,888.81 \times .021 = \$102.67 \times 10.45776 = \$1,073.70$. Mr. Clay chose Option A-6 – 100% without reinstatement to Rebecca A Clay, spouse. $\$1,073.70 \times .7981 =$
\$856.92 pension effective April 1, 2016.
DROP complete March 31, 2018.

Mr. Paseur made a motion to approve this application for DROP retirement payable under Option A-6. Mr. King seconded the motion. The motion passed 8-0.

- c) William E Cole, General Government – Plan G2 Option A-9
 100% with reinstatement
Date of birth, November 24, 1964: 51 years of age
Total credited service: 30 years 1 month 5 days
Average monthly salary for 2 highest 12 month periods, $\$6,331.71 \times .021 = \$132.97 \times 30.09703 = \$4,002.00$. Mr. Cole chose Option A-9 – 100% with reinstatement to Beth L Cole, spouse. $\$4,002.00 \times .8515 =$
\$3,407.70 pension effective April 1, 2016.

DROP complete March 31, 2018.

Mr. Paseur made a motion to approve this application for DROP retirement payable under Option A-9. Mr. King seconded the motion. The motion passed 8-0.
