House Bill

Attorney Aslinger informed the Board about the language in the House version of the Tax Cuts and Jobs Act that could expose the System and other public pension plans to Unrelated Business Income Tax (UBIT) for certain investments, such as the System's private equity investments. Ms. Paczkowski advised the Board about a letter she wrote in opposition which she will forward to each Board member.
