Ms. Paczkowski, Executive Director, has reviewed the bills and certifies that they are consistent with services provided and are within the budgeted figures of the system's financial plan.

Motion: Ms. Fugate made a motion to pay the invoices as presented. Mr. Reyes seconded the motion. The motion passed 8 - 0.

## 12. INVESTMENT MATTERS:

## **Fixed Income Waiver Update**

Ms. Paczkowski provided an update on the fixed income waivers for IR&M and Schroders. The investment held by IR&M matured and is no longer being held in the System's portfolio. In 2017, the System exited the high yield space with a dedicated manager and expanded Schroders investment guidelines to include high yield. High yield investments are made up of below investment grade instruments. Going forward, Ms. Paczkowski will continue to receive downgrade notices from Schroders but will no longer bring them to the Board for a waiver unless Schroders exceeds the parameters set for the high yield bonds (20% for below BBB and 10% for below B).

## 15. ATTORNEY COMMENTS:

Recommendation to repeal Chapter 2, Article III, Division 5 of the Knoxville City Code relating to retirement and pension matters (Memo)

- Attorney Aslinger explained to the Board that the City Law Department has been reviewing the City Code and will be making recommendations to City Council to either delete or amend outdated City Code Ordinances. As part of the project, the Law Department has requested a recommendation on the deletion of Chapter 2, Article III, Division 5 of the City Code related to Retirement and Pensions. Attorney Aslinger and the City Law Department suggest the Board recommend deleting Division 5 entirely.

Motion: Mr. Kennedy made a motion to accept the recommendation made by Attorney Aslinger and the City Law Department to delete Division 5 entirely. Mr. Owen seconded the motion. The motion passed 8-0.

#### **Legal Matters Update**

Ms. Paczkowski and Attorney Aslinger asked the Board for guidance on when they would like to take the Investment Policy Statement to City Council to update the language for references to LIBOR. The Board had previously discussed presenting a revised Investment Policy Statement to City Council at the same time as similar changes to City policies were presented. However, Ms. Gennoe plans to have the City's policies presented to Council by the time she leaves on July 15th. Rather than trying to rush the process, Ms. Paczkowski and Ms. Aslinger will prepare the revised and bring it to the Investment Committee at the July meeting and then to the Board thereafter.

- Attorney Aslinger updated the Board on the Estate of Cristianne Ailor, beneficiary of deceased member Lillard Ailor. Mrs. Ailor died in July 2021, but the Pension Board was not notified and discovered her death in April 2022. Ms. Aslinger, on behalf of the Board, filed a claim against the estate for the amount of the overpayment. The time limit for a response from the family to object to the claim has expired, such that the claim operates as a judgement against the estate. Accordingly, the Pension Board should receive repayment of the funds that were overpaid before the estate is closed.
- Attorney Aslinger updated the Board regarding the overpayment to Mr. Foglesong. Contact has continued with Mr. Foglesong along with his public defender. He has stated he plans to pay the full amount owed to the Board after he secures the funds to do so. However, he has not yet signed an Agreed Judgement.
- Attorney Aslinger updated the Board regarding Bradley Miller's disability appeal. The contested hearing is tentatively scheduled for the August Board Meeting but may be pushed back to the September meeting.
