Motion: Mr. Kennedy made a motion to affirm the Board's original decision to deny the in line of duty disability claim given that the Board was not convinced from the evidence submitted that Mr. Nation suffered a permanent mental injury caused by "a sudden or unusual mental stimulus" resulting "from fright, shock, or an acute sudden or unexpected emotional stress" that was outside "the usual stresses and strains encountered in carrying out the duties of employment." Mr. Mason seconded the motion. The motion passed 7-0.

Motion: Mr. Kennedy made a motion to affirm the Board's original decision to deny this application for a Disability Not in Line of Duty benefit based on the conflicting medical evidence, suspect timing of the disability claim, and demonstrated history of lack of credibility of Mr. Nation. Mr. Mason seconded the motion. The motion passed 7-0.
