#### - Meeting with Employee Benefits, Deferred Comp. and Sage View

Empower is the recordkeeper for the City's 457(b) Deferred Compensation Plan, and Sage View is the investment advisor. The meeting was to discuss how the pension works for employees and how it helps with financial planning for retirement. The Pension Office, City Employee benefits, and the Deferred Compensation Plan service providers are continuing to work on tools for employees to help them better manage their options at retirement.

#### - Knox County Plan A – Actuarial Valuation

Ms. Paczkowski presented the Board with a copy of the Executive Summary of Knox County's annual actuarial valuation of its Board of Education Retirement Plan as of January 1, 2024. Ms. Paczkowski advised the Board that the County was actuarially funding its portion of the Plan A benefits for certified teachers.
