16. **ATTORNEY COMMENTS**

NCPERS Amicus Brief for Chattanooga Case

The System is a member of the National Conference on Public Employee Retirement Systems ("NCPERS"). Both Attorney Aslinger and Ms. Paczkowski spoke with NCPER's Executive Director, Hank Kim, regarding a request from the attorneys of the Chattanooga Police and Fire Pension Fund to write an amicus brief to the Tennessee Supreme Court in a pending appeal regarding the Chattanooga Fund's denial of a member's request for a disability pension benefit. Ms. Aslinger provided information regarding the case and the possible implications to the System if the current Tennessee Court of Appeals ruling stands. Mr. Kim indicated that NCEPRS would consider filing an amicus brief if requested by one of its Tennessee members.

Motion: Mr. Kennedy made a motion for the Board to request that NCPERS file an amicus brief with the Tennessee Supreme Court regarding the case in question. Ms. Blanc seconded the motion. The motion passed 6-0.
